CHIP Report Card: Seibold distributed Community Health Improvement Plan Report Card for 2014-2015 and activities discussed. CHA and CHIP for 2015-2020 team is forming with community partners. Northern Region Office will present “Data in a Day” examining local data and facilitating discussion on focus areas and goals on October 2, 2014.

State ES Inspections: Due to staff changes at the State level there may be an opportunity for increased access to the ES electronic program regarding inspections.

Public Health Improvement Grant: Seibold reviewed the competitive public health improvement grant award for 2014-2015 from the State for \$8,000.

Approval to use PH Improvement Grant for National Accreditation: Seibold shared reports on benefits and cost of accreditation. M/S VanPembrook, Kmecheck for the PH Improvement and Prevention grant to be used for accreditation fees in 2015. All ayes, motion passed.
