

Employment Opportunities

Florence County Land Conservation Department is hiring grant-based, Seasonal Employee positions. All positions require working weekends, holidays, and non-standard hours. Applicants must be at least 16 years of age, have a willingness to learn, along with a friendly and helpful personality that promotes a positive respectful experience for the public and co-workers while demonstrating a genuine interest in preserving water quality. Seasonal Employees will follow Florence County's Personnel Policy requirements. Applicants must possess a valid driver's license, have transportation, and be willing to work at remote sites. All positions require the safe operation of hot-water pressure washers. The work requires some physical exertion related to rough terrain, carrying equipment, wading in shifting lake/stream beds and includes repetitive upper body motions, bending and twisting to inspect boats and trailers. A knowledge of Aquatic Invasive Species is helpful, but not required. **All positions are subject to grant requirements, and are classified as Seasonal Employee with no benefits.** Mandatory paid training for all positions will be provided.

Watercraft Inspector: Full and Part Time positions for Clean Boats, Clean Waters (CBCW) Watercraft Inspectors. Successful applicants will follow Wisconsin's CBCW protocols to assist the public with prevention, education, and techniques aimed at slowing the spread of Aquatic Invasive Species. This position requires work outdoors, professional interaction with the public, simple interviewing, and careful record keeping. **Applications will be accepted until the positions are filled.** Positions run May 27, 2022 to September 5, 2022. **Wage:** \$13.00/hour.

Aquatic Invasive Species Technician: One Part or Full Time Position: The successful applicant will assist LCD staff in meeting grant requirements. Duties include, but are not limited to water quality monitoring, Aquatic Invasive Species (AIS) inspection and reduction efforts, participating in local AIS educational activities, regional events, partnerships and statewide initiatives; conducting watercraft inspections, lake monitoring, mapping, plant surveys, along with data collection, and supporting other AIS related county programs. This position requires work outdoors, careful record keeping, and familiarity with small vessel operations. A background in environmental or water sciences is beneficial, but not required. **Applications will be accepted until the position is filled.** Position runs May 27, 2022 to September 5, 2022, but may be extended based on grant requirements. **Wage:** \$13.50/hour.
