Bids must be made on the correct Bid Sheet & Purchase Agreement and received **NO LATER THAN 4:00 P.M., TUESDAY, JUNE 8, 2021, IN THE FORESTRY OFFICE. Bids will be opened Wednesday, June 9, 2021,** at 9:00 and presented to the Forestry and Parks Committee meeting at 4:00 P.M. Wednesday June 9, 2021, at the Florence Natural Resource Center.

If there is a bid that is satisfactory, the Forestry and Parks Committee will recommend it to the Full County Board meeting at 7:00 Tuesday, June 15, 2021 for confirmation. A down payment equal to ten percent of the bid must accompany each bid. The down payment must be in the form of **cash, certified check, cashier's check, bank draft, or money order made payable to "Florence County."** Personal checks will **NOT** be accepted, and will result in the bid being rejected. Down Payments will be returned to unsuccessful bidders. Successful bidders will be given a Quit Claim Deed to the property from Florence County upon payment in full. Payment in full is due by 4:00 P.M., Tuesday **July 13, 2021.** *The parcels and/or buildings are sold in an "as is" condition. These parcels have not been inspected for hazardous materials. Florence County assumes no Liability for any condition of the properties listed.*
